NOTES FROM THE PRESIDENT'S DESK

We are again off to a good start for the new year in Northwest Crossing. Thanks to all who attended the January 23rd Annual Meeting. Thanks to Deb, Wendy, Dusty, Northwest Crossing Elementary School, and the Patriot HOA Management team for their efforts to make it happen. Your 2020 Board of Directors are in the left column on this page. Board meetings are monthly on the third Tuesday at 6:30 pm at the Weybridge Clubhouse.

As of this writing approximately 80% of our members have either paid or made payments on their 2020 annual assessment. THANK YOU!! Timely payment saves you and the Association money. Payment was due January 1st. Late fees commence on February 1st. Payment or payment plan can be arranged at the Weybridge office or directly with Patriot.

As briefed at the meeting, Armstrong, Vaughn and Associates, Inc. completed their audit of our books and gave us a good report. We also had a reserve study done by Reserve Advisors, LLC. We are making good progress in building a reserve fund to cover future costs of major facilities repairs, replacements and upgrades. The efforts of all last year culminated in our receiving the CAI Community of the Year award (see more on page 9).

Your Association continues to work to keep our facilities in good condition. A list of projects completed over the last few years is on page 11. Projects on our wish list for 2020 include: Weybridge Pool parking lot repaving, various areas of fence replacement, irrigation system replacement, various security lighting replacements/upgrades, twelve new and improved entry signs, park signage replacement, hydro-mulching of the fields at the Sportsplex, shingle and siding replacement on the storage building at the Sportsplex, lighting upgrade at the Dover Ridge tennis courts, additional mulch in playground areas, and new gates at Misty Brook Park parking lot.

A big thank you to all the volunteers who stepped up in 2019 to help make NWC a better place to live. With nearly 4,000 homes in a relatively small area, there is bound to be some conflict between neighbors. The on-site office frequently receives resident requests to resolve issues that the HOA does not have the authority, ability, or responsibility to handle. This page features a few of those issues for your review.

The HOA cannot mediate in neighbor disputes.

Outside of enforcing deed restriction violations, the HOA cannot be involved in disputes between residents. Bexar County has a FREE service with trained professionals at your disposal. Bexar County Dispute Resolution Center services are easy to use, and the staff are very friendly and helpful.

Their vision is *Resolving Conflicts*, *Rebuilding Relationships*, and their goal is to help residents avoid the expense and hassle of going to court. All matters are confidential, mediations are held in a secure, neutral setting, and they have daytime and evening hours. The Center staff can contact the neighbor and extend an invitation to engage in mediation on your behalf. Participation of both parties is, however, voluntary. Again, these services are available at NO COST to you. Visit their website at www.bexar.org/drc.

The HOA cannot replace cluster mailboxes.

These belong to the United States Postal Service, and they do not give the HOA authority to maintain or replace damaged boxes. Our security and Board have worked together to notify the USPS and SAPD of vandalism and request repairs; this is only effective as a supplement to residents' reports. Residents on the north end of Gallery Ridge recently received a new cluster box as a result of this collaborative effort.

We cannot emphasize the importance of not only posting on social media outlets to encourage your neighbors to take precautions but also *REPORTING* to the appropriate authorities. If you believe your package delivery has been stolen or your cluster mailbox has been broken into, please report it to *ALL* below—keep your case numbers and share it with each agency you report to:

The HOA cannot "run plates" or write tickets.

Streets in NWC are not private; they are owned, policed, and maintained by the city. SAPD is the enforcement agency capable of identifying owners of vehicles through a vehicle registration database; the HOA and its contracted security patrol do not have access to this database.

The HOA can enforce its own restrictions on parking. These include inoperable vehicles stored on your property, trailers and recreational vehicles stored on or in front of your property, basketball goals blocking the sidewalk or in the street, and parking in front of mailboxes.


If a vehicle is parked and blocking your driveway, please report it to NWC security. If a vehicle is parked illegally, stored on the street for more than 48 hours, oversized, or inoperable (including vehicles with expired registration), please report it to SAPD non-emergency. Please be considerate and avoid parking immediately in front of others' properties. If you are hosting guests for an event at your residence, it is polite to let your neighbors know to expect extra vehicles on the street.

Please note: Overnight parking is not permitted in NWC park, pool, or clubhouse parking lots. Vehicles may be towed at owner's expense.

The HOA cannot remove dead or living animals.

These casualties must be reported to the City's solid waste department for disposal. Call 3-1-1 or use the 3-1-1 app. The City will not pick them up unless they are at the curb, and generally they must be bagged. This includes roadkill. HOA management and security will report roadkill as they see it, but it's best not to assume it has already been reported.

Lost living dogs and cats must be reported to Animal Care Services (ACS) at 3-1-1. If the animal is contained, ACS will be more likely to successfully captured it. Living pests—skunks, possums, etc.—can only be removed by a professional pest control service or by the resident.

ID CARD TIPS:

- Stickers must be placed on the ID card by an NWC HOA staff member.
- One member of the household can bring cards for permanent residents at one address. However, proof of residency must be provided to renew the card of residents 18+ who are not the homeowner.
- Lost cards issued within 18 months require a \$10 replacement fee. Must be present to have photo taken and receive the ID.
- Renter cards expire with their lease and must be renewed with new lease and applicable fees.

NWC LITTLE FREE LIBRARY

NWC would like to introduce you to one of its newest residents! Our Little Free Library joined the NWC neighborhood in November last year. It resides in between the Weybridge pool and Weybridge Clubhouse parking lots. The Little Free Library is friendly to ALL ages! Inside this cute little house you will find a wide variety of books—nonfiction and fiction—for all ages and different interests. Please, come get acquainted! We hope you might even meet a neighbor while you're there and maybe make a new friend.

The addition of our Library was part of the Little Free Library movement's 10th anniversary. "In 2009 Todd H. Bol created the first Little Free Library book exchange and placed it in his Hudson, Wisconsin, front yard in tribute to his mother, who had been a teacher. Ten years later, his idea had snowballed into a worldwide book-





sharing movement. Because of this global book-sharing phenomenon, millions of books have been shared and thousands of neighbors have connected for the first time! The Little Free Library nonprofit organization is at the heart of this global movement to inspire a love of reading, build community, and spark creativity (https://littlefreelibrary.org/10years/)."

NWC resident, Riley Roberts, designed and built our Library as part of his Eagle Scout project with mentors, friends, and family. By soliciting donations of funds and books, Riley was able donate the Library with an official registered Little Free Library plaque and well over 100 books to keep our Library stocked for some time. Riley was awarded the rank of Eagle Scout in December.





IS YOUR SIDEWALK HIDING?

Did you know City Ordinances require sidewalks to be maintained by property owners as an extension of their front yards?

This includes:

Keeping sidewalks free from any defects and hazards or obstructions such as basketball hoops, parked cars, trash cans, shrubbery, or fences. (Code of Ordinances, City of San Antonio, Sec. 29-11, and Sec. 6-1) Citation and Fine of up to \$500.00 (Sec. 1-5)

Keeping all trees and shrubs on the premises well trimmed so they will not overhang the sidewalks (below 8 feet) or streets (below 15 feet) in such a manner as to interfere with free passage. (Code of Ordinances, City of San Antonio, Sec. 29-10)

Please help keep our neighborhood walker/runner friendly!

NWC HOA COLLEGE SCHOLARSHIP

Graduation is approaching!

NWC HOA offers two \$500 scholarships annually.

Applications will be available in the on-site office March 6th and must be submitted no later than Friday, May 1st at 12:00 pm.

Carefully read all the requirements when you apply. Only graduating seniors in high school who will be attending college in the fall of 2020 or those already attending college may apply.

NOW HIRING POOL GATE GUARDS

NWC is listening to resident feedback with regard to the pools. While we cannot segregate pool use by age to create adult only hours due to legal limitations, we are working to extend pool hours to extend both the season length and pool hours. In addition to opening earlier in May and closing later in September, we hope to open before noon and stay open an extra hour. We also are working to have at least one pool open seven days a week.

A gate guard would be posted to admit residents with valid NWC photo ID cards into the pool area when lifeguards are not scheduled. A gate guard would also enforce pool rules but would not be required to be certified in lifesaving, First Aid, or CPR. When a gate guard is on duty children would be required to be accompanied by an adult.

The gate guard would be a part-time position. Hours for gate guards will likely be available in the morning and evening. If you are interested in applying for a position as an NWC pool gate guard, please inquire at the on-site office.

JOB OPPORTUNITIES FOR TEENS

LIFEGUARDS

Pool season will be here before we know it, and that means NWC HOA will be hiring lifeguards. To be eligible to apply, American Red Cross Lifeguard Training, First Aid, CPR certifications are required. These are offered through the NISD Aquatic Center. NWC members who are hired as lifeguards and work the full season may be eligible for reimbursement for their training.

REFEREES

NWC Youth Fall Soccer Program is hiring soccer referees for its fall season. Applicants must be 14 or older and have some experience playing soccer. Referee experience is desirable but not required. If hired, referees must commit to training and 8-9 weeks of Saturday morning shifts.

With every January 1st comes the hope of a promising new year...

...and the HOA annual assessment.

There's a headache-free approach to paying the assessment. It's available to anyone with **online "bill pay"** services through their bank. Most banks offer customers the convenience of paying bills online.

Turn your annual HOA assessment into smaller automatic monthly payments that fit your budget. Here's a quick crash course...

Step 1: Login to your online banking site

Step 2: Locate the web bill pay service on the webpage

Step 3: Set up a New Payee

Most web bill pay services will ask for:

✓ Payee name: **NWC HOA**

✓ Payee mailing address: **c/o Patriot**

- Your account number: look for your 5-digit account number on your most recent annual statement or contact the on-site office
 - * MAKE SURE YOUR ACCOUNT NUMBER IS ALSO ENTERED AS A MEMO ON THE CHECK
- ✓ Amount of monthly payment: for an assessment of \$250, \$20 monthly will get you pretty close
- ✓ Frequency of payments: choose once a month, twice a month, etc.
- ✓ Date of payment: choose first of the month, middle, end, etc.
- When you would like payments to end: choose to end them on a specific date, after a certain number of months, or not at all, etc.

Step 4: Confirm and Complete Setup

The bank will debit your account monthly for the amount you chose and print and mail checks with your NWC HOA account number to Patriot who will post each monthly payment to your account. By the time you get your statement in December you will have nearly *paid off* your upcoming annual assessment—**NO FEES** from your bank or HOA. **Easy and headache-free!** All that's left is to pay the remaining balance by Jan 1st.




