NOTES FROM THE PRESIDENT'S DESK

I hope everyone has avoided "the bug" and is doing well. Following government guidelines, NWC has started to get back to normal one step at a time. We have been able to reopen the Weybridge on-site office with additional safety protocols required by patrons (masks, distancing, etc.). Visit *nwchoa.org* and our Facebook page @NWCSATX for hours and more details.

We are working with various government agencies to understand the evolving steps and conditions to try to open the pools. Limiting occupancy, social distancing, restroom and furniture use, and sanitizing are all part of the use requirements. Again, check our online sources for up-to-date information.

Playground and exercise equipment are still off limits, but we hope to see changes there in the coming weeks.

We have completed the last of the parking lot gate installations and are continuing the metal fence painting. Landscaping and other maintenance services also continue.

Thank you to the 96% who have taken care of their annual assessments.

We are seeing more non-residents trespassing in our parks, so we are focusing security efforts to enforce ID checks and calling police, as necessary. An NWC resident was recently attacked by a pair of unleashed dogs in Weybridge park while the owner watched. DO NOT allow your animals to run free. Also, as more folks are out walking their dogs PLEASE be courteous and pick up their droppings.

Bexar County is reporting an increase in property crime over the March-April time frame. Vehicle theft increased 11% and burglaries increased 18% over the same time last year. Please be vigilant; secure your property and report suspicious activity.

For several years, we have worked with our friends at District 6 to encourage the City to review the streets, and that has paid off as several of the streets in NWC have been repaved. With the current budget crunch, I expect that to end. The pothole repair crew is still very active, so call 3-1-1 or go online to report any street issues. They have been responding.

Thanks and stay well.

We continue to encourage residents to stay home if possible, to contact us by phone & email, and make payments online or through the drop box at the on-site office.

2020 NWC POOL SEASON

NWC residents who choose to use the pools this season will see some changes to the schedule, rules, and staffing. Bear in mind that all changes are intended to not only meet City, County, and State guidelines and requirements, but also to protect our residents and staff.

On the following pages you will find the 2020 NWC Pool Schedule and NWC Pool Rules & Regulations. Please note the daily detailed schedule that includes periodic closures at the bottom of the Schedule.



Rules & Use Highlights

Pool hours extended

At least one pool will be open 7 days a week. Pools open at 11 am, close at 8:30 pm.

Maximum occupancy inside the pool area is 25 persons

This limit complies with 25% capacity mandates.

No lifeguards on duty.

Minors must be accompanied by an adult (18+) from their household. Pool attendants will admit residents and ensure rules, including social distancing protocol, are followed.

Pool area open for 90 minutes, closed for 30 minutes

Pool attendants must sanitize specific areas and monitor pool chemicals during this time.

Signed waiver required for all persons in pool area

Waiver must be signed and turned in to NWC On-site Office before the first visit to the pool. Verification of signed waiver will be issued to each individual and must be shown to pool attendant with NWC photo ID card for admittance. Parents/guardians will sign waiver for their children. See page 6 for a Waiver Wipeout event.

No restrooms

Residents will not have access to pool restrooms. They should use periodic pool closures to return home and use the restroom.

The following NWC programs have been canceled for the 2020 season:

- Dolphins swim team
- Water fitness classes
- Youth swim lessons

NWC PHOTO ID CARDS WITH 2020 STICKER

REQUIRED FOR ALL NWC FACILITIES AND PARKS

If you have paid your annual assessment, your NWC photo ID card must be updated with the 2020 sticker to be valid.

The NWC On-site Office has resumed issuing new ID cards.



ID CARD TIPS:

- 2020 sticker must be placed on the ID card by an NWC HOA staff member. Pool attendants do not have access to stickers.
- One member of the household can bring cards for permanent residents at one address. However, **proof of residency** must be provided to renew the card of residents 18+ who are not the homeowner.
- The replacement fee for a lost card is \$10.
- Resident must be present to have photo taken for the ID.
- Tenant cards for those renting in NWC expire with their lease and must be renewed with updated lease and applicable fees.

Northwest Crossing Pool Rules & Regulations

The following rules and regulations are for the protection and benefit of all to assure safe and sanitary operation of the pool facilities. Your cooperation in abiding by these conditions will afford pleasant relaxation and recreation for all members/guests. Parents are requested to caution their children to observe all rules and regulations.

Failure to comply with these rules shall be considered cause for any action deemed necessary by the Management or Board of Directors, including the temporary suspension of violators from the use of the pool area.

The pool manager will oversee qualified lifeguards/attendants, all of whom will be under the direct supervision of the Association. All members and guests using the pool will be required to register with the attendant. Your assistance is not only needed but also required to make the pools safe and enjoyable facilities

- 1. All members ages six (6) and older must bring their ID cards to be admitted into the pool. One family member may not sign in others in the same household as guests.
- 2. No one shall use the pool unless it is officially open, and lifeguards/attendants are on duty.
- 3. The on-duty lifeguards/attendants will oversee the pool operation and are responsible for the enforcement of the Rules and Regulations.* All persons must obey the instructions of the lifeguards/attendants.
- 4. The Association, lifeguards, attendants, and Board of Directors will not be responsible for loss or damage to any personal property of any kind
- 5. All persons using the facility do so at their own risk in conformance with the rules and regulations. Any person may be suspended from the recreational facilities, at the sole discretion of the lifeguard/attendant in charge, for violations of the rules and regulations or for any other reason, which in their judgment, constitutes a hazard to others.
- 6. After a person has been removed from the pool area, a written notice will be given to the homeowner. After removal, the person will be suspended from using the pool area, and the ID card will be confiscated. Reinstatement will occur upon approval of the Board of Directors only.
- 7. No pets are allowed in the pool area.
- 8. Admission will be refused to all persons having any infectious diseases, colds, nasal or ear discharges, or any communicable diseases of any kind.
- 9. Glassware is forbidden in the pool area.
- 10. No alcohol is allowed in the pool area.
- 11. Food may be allowed in the pool area; however, no cooking will be allowed inside the fenced area except during private parties at Association's discretion. No food, drinks, bottles, or gum chewing is permitted at the pool's edge or in the pool.
- 12. All trash such as food wrappers, soda cans, etc. must be placed in containers provided for such use.
- 13. Smoking is allowed in designated areas only.
- 14. Skates, skateboards, bicycles, and similar devices will not be allowed inside the pool area.
- 15. GUEST POLICY: GUEST POLICY IS TEMPORARILY SUSPENDED DUE TO COVID-19. Each adult (18+) member is permitted to sign in up to 4 guests at either pool. A resident of NWC HOA cannot be signed in as a guest. Resident must accompany guest(s) for duration of their stay.
- 16. Children under eighteen (18) must be accompanied by an Association member 18 years or older.
- 17. SWIMMING ATTIRE POLICY: Proper swimming attire must be worn by anyone entering the water. No cut-offs, diapers, street shirts or shorts, etc. will be allowed in the pool. A plain white t-shirt may be worn for additional sun protection. Indecent exposure will not be allowed in the pool area.
- 18. Children must be proficient swimmers to be allowed in the deep area of the pool.
- 19. Floating devices attached to the swimmer for safety is allowed in the shallow end only.
- 20. No inner tubes, balls, Frisbees, snorkels, glass lens face masks, or glass lens goggles may be used in the pool. Nerf balls and similar playing equipment are allowed at the discretion of the lifeguards/attendants if their use does not interfere with other people.
- 21. Running, horseplay, wrestling, ball playing, or causing undue disturbance in or about the pool is not allowed.
- 22. Spitting or spouting water, dunking, running, scuffling, or horseplay of any kind is not allowed. Abusive or profane language will NOT be tolerated.
- 23. No loitering on ladders.
- 24. No diving.
- 25. Pool games are allowed at the discretion of the lifeguards/attendants.
- 26. Injuries should be reported to the lifeguards/attendants immediately.
- 27. The attendants will close the pool area after 1 ½ hours to perform required sanitization and chemical checks. Everyone will leave the pool area for approximately 30 minutes before re-entry.
- 28. No pool equipment, furniture, etc. may be used during COVID-19 operations.
- 29. You may bring your own chairs to use.
- 30. Radios and sound equipment must be kept at a reasonable volume and will be monitored at the lifeguards'/attendants' discretion. No loud radios or sound systems will be allowed.
- 31. RESTROOMS ARE NOT AVAILABLE DURING COVID-19 OPERATIONS.
- 32. No loitering in the restrooms or parking lots.
- 33. Pool area parking lot must be vacated at the end of the day.
- 34. No photography or video recording is allowed without approval of the Association.**

*The lifeguards/attendants have the authority to use their judgment in making decisions regarding the enforcement of the Rules and Regulations. Any disagreement over the rules and regulations or the method of enforcement should be directed to the Board of Directors at nwc@nwchoa.org.

**Lifeguards/attendants may allow photography/video recording with approval of those being photographed or recorded. Private parties, social events, and sporting events may allow photography/video recording with permission of the individuals hosting the event (i.e. swim team, water aerobics, parties).

These rules and regulations may be amended or added to at any time by the approval of the Board of Directors.

ADDITIONAL COVID-19 OPERATION POOL RULES

- * All residents MUST practice social distancing.
- * Facility 25 maximum occupancy inside gates.
- * No public restrooms attendants only will be permitted usage and will wipe down after use.
- * Swim at your own risk; NO LIFEGUARDS ON DUTY.
- * 2-hour maximum facility time 2-hour blocks that include 30 minutes of transition and sanitization time. Start at 11 AM, end 9 PM when open.
- * All residents sign NWC Association waiver prior to arriving at pool facility. ID Cards will be marked with special sticker.
- * Must be 18 years of age or older and in same household to sign in a minor under the age of 18 no guests outside NWC Association.
- * Pool attendant will visually verify ID & update sign-in roster. Residents will not touch roster, pen, etc. ID cards will be returned upon leaving the facility.
- * Follow social distancing markers indicated inside pool area and at entry to the pools.

NOTE: COVID-19 Operation Pool Rules are subject to change with updated City, County, and State guidelines and requirements.

NWC COVID-19 PRECAUTIONS

• NWC On-site Office

We are open and will have extended summer hours beginning June 2nd. We continue to encourage residents to stay home and contact us by phone and email. We also encourage residents to make payments online or through the drop box at the on-site office. Patriot HOA Management office is closed; customer service is available by email.

• NWC Parks & Tennis Courts

Playground and exercise equipment and parking lots are closed. Walking trails at Dover Ridge Nature Park and Misty Brook Nature Park are open and accessible by foot. NWC parks are private for residents only. Tennis court use is limited to four persons per court; must present proof of residency to NWC security for access.
